#### About the data in this report



#### Your Voice survey - final results for November 2022

- Type: An omnibus, controlled-access online CFIB survey.
- Active dates: November 10-28, 2022.
- Results: Based on responses from 3,264 CFIB members who are owners of Canadian independent businesses, from all sectors and regions of the country.
- For comparison purposes, a probability sample with the same number of respondents would have a margin of error of +/-1.7%, 19 times out of 20.










### **Business recovery**





#### State of Small Business



Small businesses are still feeling the impacts of the pandemic, with more than half making less than normal sales (52%), about 3 in 5 still reporting pandemic related debt (58%) and about 3 in 4 indicating they are still under pandemic stress (71%).





# As of November 2022, over 1 in 2 Canadian small businesses have not yet returned to normal revenues



(By province and sector, % response)





(By province and sector, % response)







# Among businesses that are still holding debt incurred due to the pandemic (58%), the average amount held is \$114,137







# 71% of business owners are still under pandemic stress, with nearly 1 in 8 (13%) saying they have not recovered at all (% response)







### Receiving good government customer service is of high importance to businesses (% response)










# Workplace culture and conduct





More than 1 in 3 business owners said they've hired people who never showed up or stopped coming into work shortly after starting (36%) and/or had job candidates who stopped responding during the application or interview process in the past 12 months (37%) (By province and sector, % response)

National Results: Yes, job candidates stopped responding during the application or interview process = 37%; Yes, new hires never showed up for work or stopped showing up shortly after starting = 36%; Other = 3%; No = 26%; Not applicable - We have not tried to hire = 20%; Don't know/Unsure = 1%.




### Regarding replacement and essential workers in federally regulated workplaces (% response)
